#### 1. Classifying migration

#### (drivers)

- · Citizenship and regional citizen movement
- Forced migration (political, economic, climate-based, etc.)
- Family reunion
- Reception state economic policy

#### But not (generally):

- Laws: national, EU, and/or international
- Failures in state border control





#### 2. Immigration laws (Europe)

- The laws of sovereign states: constitutions, legislation
- EU law: EU Treaty, TFEU, Regulations, Directives, Charter of Fundamental Rights, etc.
- Council of Europe Conventions (inc. ECHR)
- International treaties (multilateral): e.g., ICCPR, Refugee Convention, Convention on the Law of the Sea
- International treaties (bilateral): e.g. UK-France treaty on the prevention of dangerous journeys



## 3. Administrative control and cooperation

- National border guards and immigration officers
- EU institutions: Frontex, etc.
- Bilateral administrative co-operation (e.g. re-admission, maritime, etc.)



4. Links between irregular migration, regular migration, and the structure of national economic life

• The structure of employment law: job security, employment law protection, agency workers, part-time work, minimum wages, minimum income, outsourcing and independent contractors (as workers)

• The structure of social policy: residential tenancies (security of tenure), residential mortgage availability, contribution-based social insurance (social security), minimum income/accommodation (dignity protection)

- The structure of economic policy: regulatory frameworks, credit supply, monetary policy, fiscal policy, regional investments
