### THE SOCIAL SIDE

The Hague is a truly multicultural city with an 800-year history, and is the seat of the government in the Netherlands. While widely known as the home of the International Court of Justice, the city hosts over 200 international organisations, earning it the title of 'International City of Peace and Justice'. Besides being a leading stage for international law and diplomacy, the long history of the city is also reflected in its medieval architecture, where modern buildings blend in, creating a sense of both continuity and progress. Several well-known museums highlight the city's cultural life and history.

There are thus many flavours to the Hague, including many cobbled streets offering antiques, lifestyle and design stores, trendy boutiques, and galleries. For the more curious, The Hagse Markt (The Hague Market) is a vibrant open-air market located in the multicultural Transvaal district, just a short tram ride from the city centre. Scheveningen, a lively coastal neighbourhood of The Hague, offers a vibrant food scene and has something for every taste. Along the Dutch coast, a breathtaking panorama of the North Sea and its endless horizon awaits.

Social events during conference include a Drinks Reception at the Residence of the Czech Ambassador to the Netherlands in The Hague, located in the centre of The Hague in the close neighbourhood of the Noordeinde Royal Palace and a "Stakeholder" visit to the ICC. There will be a second Drinks Reception, graciously hosted by The Netherlands Bar at Pulchri Studio, a Dutch art studio, before the Gala Dinner being held in the Botanica Restaurant at the Voco Hotel in the centre of The Hague – we hope you'll agree these will be great networking and social opportunities to meet new colleagues from across Europe and beyond.







### THE NETHERLANDS BAR

The Netherlands Bar (NOvA) is the statutory professional organisation for all advocates in the country, established by the Act on Advocates (1952). It is funded entirely by members' contributions, ensuring independence from the government. Organised across eleven judicial districts, each with its own local bar and president, the NOvA oversees professional standards, supervision, and training. Nationally, it is governed by the general council, led by the secretary general and supported by an office of around sixty staff. The NOvA issues regulations, manages bar registration, and requires continuous professional education. As of January 2024, 18,513 advocates are registered. Internationally, it is a member of the IBA and the CCBE, reinforcing its role within the global legal community.

We asked Sanne Van Oers, President of The Netherlands Bar, three burning questions and we are most grateful to her for taking the time to respond.

### 1. Why is the Hague considered an important legal centre and what role does the Netherlands Bar play in it?

The Hague hosts key international courts, tribunals and organisations, such as the ICJ, the ICC, the PCA, Europol, Eurojust and OPCW. The city also has a tradition of peace and justice; The Hague Conventions of 1899 and 1907 laid the foundation for international humanitarian law and the Peace Palace has become a global symbol of international dispute resolution. The Netherlands Bar ensures an independent and well-regulated legal profession, making sure both Dutch and foreign lawyers can operate effectively in this unique hub of international justice.

#### 2. What are the current issues and challenges you are dealing with at the bar?

At the Netherlands Bar we are addressing a wide range of issues. As part of our statutory duty to promote effective legal protection, we are committed to ensuring adequate access to justice for persons in need of legal protection. A key priority in this regard is safeguarding a sustainable system of government funded legal aid which also means that there must be enough legal aid lawyers. That is what concerns me. Another important issue is the safety of lawyers. The Netherlands Bar has taken several initiatives to make lawyers more resilient and aware of potential risks. Unfortunately, an increasing number of lawyers are facing aggression, threats, and/or intimidation in the exercise of their profession.

### 3. What are your personal favourite sights or tips for our conference delegates – any must-sees in the Hague?

I suggest visiting the ICC which is a highlight of the conference programme, offering a unique opportunity to gain an understanding of how the ICC pursues justice in prosecuting serious crimes like genocide, war crimes, and crimes against humanity. For the delegates who appreciate culture, I would like to recommend the street "Noordeinde" where you find quite some national heritage sites including "Noordeinde palace", the workplace of King Willem-Alexander and Queen Máxima. A visit to "Scheveningen Beach" is a good choice too, whether for a relaxing walk, a drink by the sea, or simply some fresh air. It is just a short tram ride from the city centre.

### SPEAKER BIOGRAPHIES: KEYNOTE



#### **JUDGE KIMBERLY PROST**

Judge Prost was appointed a Judge of the ICC from 11 March 2018, for a term of nine years. Prior to her election as judge of the ICC, Judge Prost served as Chef de Cabinet for the President of the International Criminal Court for a two-year term.

Before joining the Court, she was appointed in 2010 as the first Ombudsperson for the Security Council Al Qaida Sanctions Committee.

In July 2006, after election by the United Nations General Assembly, she was appointed to sit as an ad litem judge of the International Criminal Tribunal for the former Yugoslavia on a multi-accused trial (Popovic et al) related to events at Srebrenica and Zepa.

Earlier in her career, Judge Prost worked for the Canadian Department of Justice for 18 years appearing before all levels of the Canadian courts, including the Supreme Court.

For 7 years she served as Director of the International Assistance Group which is responsible for extradition and mutual legal assistance matters for Canada. She participated in negotiating over 40 extradition/mutual legal assistance treaties and was a member of the Canadian delegation for negotiating the Rome Statute of the International Criminal Court and related documents, as well as the UN Conventions against Transnational Organised Crime and Corruption.

Judge Prost also held managerial positions with the Commonwealth Secretariat and the UN Office on Drugs and Crime delivering a range of programmes for States on international cooperation, money laundering and asset forfeiture, counter terrorism, implementation of the Rome Statute, and combating organised crime and corruption. Judge Prost graduated as a gold medallist from the University of Manitoba Law School.

The keynote speech will be preceded by a brief welcome from Abigail Holt, barrister of Garden Court Chambers & Leader of the European circuit & Professor Dr Machiko Kanetake, Academic Director of the Asser Institute & Professor of International Law & Security Governance, University of Amsterdam.

#### **LEILA GHAHHARY**

Leila Ghahhary is on international barrister called to the Bars of England & Wales and Ontario, Canada. She is a co-founder and partner at Ghahhary Thomas LLP (Toronto) and a member of Lincoln House Chambers (UK), practising across public, regulatory, and international law in both jurisdictions.

She is ranked as a leading barrister by the major legal publications in the UK and Canada – Legal 500, Chambers & Partners, and Benchmark Litigation.

Leila has been appointed to the UK Attorney General's Panel of Counsel, the Equality and Human Rights Commission Panel of Counsel, and the Panel of Specialist Advocates in Health and Safety and Environmental Law.

She has a significant public inquiries practice, currently acting as Counsel to the Cabinet Office and No. 10 Downing Street in the UK Covid-19 Inquiry and recently as Counsel to Canada's Foreign Interference Inquiry.

Leila's international practice includes European law, public international law, international criminal law and international human rights. Her work has involved matters concerning ICJ proceedings, the application of universal jurisdiction and atrocity crimes. It also includes acting as the Senior Legal Advisor to on international NGO.

In 2023, Leila completed her second Moster of Laws at Columbia University, having been awarded the Porker School Certificate of Achievement in International and Comparative Law. Leila's scholarship was focused on Public International Law, Global Governance, and International Human Rights. During her time in New York, she served as on editor for the Columbia Human Rights Law Review and Boord Member for the Columbia Society of International Law. Leila was also selected to undertake a leadership in law programme and on Externship with UN Women, during which she spent time working at UN Headquarters New York on peace and security matters relating to UN Women's role on the Security Council. Leila sits on the Committee of the European Circuit.





#### **EMILY GILLETT**

Emily is a Senior Research Scholar at the Institute for Law & Al (Law Al), focusing on the regulation and governance of general-purpose and frontier Al under the EU Al Act. Before joining Law Al, Emily gained experience in the Al policy field, leading the European Al Governance team at a non-profit organisation dedicated to aligning Al through better governance.

Prior to embarking on a career in AI, Emily was on English barrister (Lincoln's Inn) & Hong Kong solicitor, specialising in high-profile cross-border commercial fraud and asset recovery litigation.

With fifteen years of courtroom experience, she has been instructed on industry-leading cases in London, Grand Cayman, Guernsey and Hong Kong.



#### **DR. THOMAS SEEBER**

Dr. Thomas Seeber is a lawyer with many years of experience in Legal Tech and Al, also as a partner in renowned law firms in Vienna, Innsbruck and London. He has specialised in real estate law, banking and finance, capital markets and corporate law and, in particular, New Technologies and Legal Tech. Dr. Thomas Seeber has put his experience in Legal Tech into practice as the founder of Realestate8 Technologies GmbH, for which he has received numerous awards.

He is an expert in the application of technology and digital solutions in the field of law and gives numerous lectures on the subject. With his training at the MIT Sloan School of Management on Al and its implications for business strategies, he has extensive knowledge of the latest technological developments and how they can be used to make legal processes more efficient and cost-effective. Thomas Seeber is a leading expert when it comes to Al and Al-Technologies in the (banking) practice.





#### PROFESSOR DR MACHIKO KANETAKE

Professor Dr Machiko Kanetake is the Academic Director and the Chair of the Executive Board of the T.M.C. Asser Instituut and Professor of International Law and Security Governance at the University of Amsterdam.

Before joining Asser/UvA, she was the programme director (2023-2025) and coordinator (2015-2021) of the Master's Programme in Public International Law at Utrecht University. Since September 2024, she is a Board member of the European Society of International Law (ESIL).

She served in 2017-2024 as an Editorial Board member of the Leiden Journal of International Law. Machiko's research interest lies in the interactive domains of security, human rights, and technology.



#### **DEE MASTERS**

Dee Masters is a technology and discrimination specialist. She was Legal 500's Employment Junior of the Year in 2024 and 2022.

Dee is a leading practitioner in the technology space in relation to the interplay between artificial intelligence, equality law, human rights and data protection. She works with private companies, NGOs, trade unions, regulators and individuals.

Dee is currently representing the Equality and Human Rights Commission in Great Britain in its intervention in a judicial review concerning the use of Live Facial Recognition Technology by the Met Police. In 2023 and 2024, Dee drafted an Al Bill focused exclusively on the employment relationship for the TUC along with Robin Allen KC and colleagues in chambers. In 2022, they worked with DCMS and CDEI on legislative coherence issues. In 2022, Dee was a lead speaker at the employment workshop for CENELEC of the European Commission on technical standards in Al.

In late 2021, Dee and Robin were commissioned by the UN Special Rapporteur on the rights of persons with disabilities and the office of the UN High Commissioner for Human Rights in relation to the effects of AI, ML and ADM for persons with disabilities. The Special Rapporteur's thematic report was then presented to the UN Human Rights Committee on the 14 March 2022. On 25 March 2021, the TUC published a legal opinion by Dee and Robin called "Technology Managing People – the legal implications". This report has been widely cited in the discussions about future regulation of AI systems in the workspace. During late 2020 and early 2021, Robin and Dee devised and delivered a training programme for the Council of Europe, in conjunction with the CDEI, for UK regulators on discrimination and AI. The programme has been rolled out to regulators in France and Spain.

#### THIS WILL BE A LIVELY SESSION AS PER THE CONFERENCE THEME "LAWYERING IN A PHASE OF UPHEAVAL".

The range of problems facing lawyers and the legal profession are immense. Many jurisdictions are dealing with the same problems from different angles. The leaders will address topics as diverse as:

Being required to work electronically whilst being forbidden from taking laptops or digital devices into prison; the massive backlog of criminal cases and challenges to the criminal justice system in the UK; attacks on lawyers and judges, including sanctions against the ICC; policies to support lawyers responding to the challenges of AI; lawyer / client privilege and duty of confidentially potentially under attack by the proposed new "chat control" EU Regulation; the challenges caused by limited legal aid for civil cases in Ireland; and challenges to the Rule of Law and the basic tenants of democracy in the USA. Recent civil law work includes successfully arguing in *Musueni & Amah -v-lreland & Ors* [2024] IEHC 523 that the statutory regime whereby 'aged out' juveniles convicted of murder receive a Life sentence was inconsistent with the constitutional guarantee of equality per Article 40.1 of the Constitution. This constitutional challenge necessitated legislative amendment: Criminal Justice (Amendment) Act, 2024.

He leads the State defence in the CJEU in C-528/24 Boothnesse, where the Supreme Court of Ireland has referred questions of law on the compatibility of Section 22 of the EAW Act 2003 and Art. 625(2) of the EU-UK Trade and Cooperation Agreement with Arts. 47-50 of the EU Charter of Fundamental Rights.

He is frequently entrusted to prosecute and defend in cases of murder, manslaughter, rape and other serious crime. In 2019 and 2020, he represented the OPP in OPP -v- F.E where the Supreme Court laid down sentencing guidance to be followed by judges in rape cases.

In 2018, he represented the first person acquitted in a murder case defended under the Criminal Law (Defence and the Dwelling) Act, 2011.

Séamus is a graduate of University College Dublin / De Paul University, Chicago and the University of Oxford where he was a Parker Scholar at Lady Margaret Hall.

Séamus is the Vice-Chair of the Council of the Bar of Ireland and has been a Member of the Council since 2019. He is a Member of the Faculty of the Bar Council Advanced Advocacy Trainers and a former member of the Barristers' Professional Conduct Appeals Tribunal.





#### **BARBARA J. HOWARD**

Barbara J. Howard practices exclusively in the area of family law. She handles complex asset and property division cases, child custody cases, support for both children and spouses, tax issues related to divorcing parties and prenuptial agreements. Ms. Howard has also handled Hague Convention cases. She has been certified as a specialist in family relations law by the Ohio State Bar Association since 1999. #### **JAMES ONALAJA**

James Onalaja is a criminal and regulatory barrister practising from 187 Chambers, Temple, London. His practise focuses on: serious, complex and violent crimes including matters with transnational, international criminal law and human rights complexities. He is admitted to the International Criminal Court's (ICC) and the Kosovo Specialist Chambers' (KSC) lists of counsel.

James recently completed a posting in The Hague with the ICC's Office of Public Counsel for the Defence, assisting with its duties of representing, protecting and promoting the interests of the defence and unrepresented suspects. He conducts international trial monitoring and reporting on behalf of EuroMed Rights and the Bar Human Rights Committee.

He is a member of the International Criminal Court Bar Association (ICCBA) Training Committee and Chairs its Legal Advisory Committee.



#### **WARD FERDINANDUSSE**

Ward is the Deputy Specialist Prosecutor at the Kosovo Specialist Prosecutor's Office, which investigates and prosecutes war crimes and crimes against humanity in the period 1998-2000 as well as obstruction of justice offences. As prosecutor in the Dutch National Public Prosecutor's Office in 2008-2021, Ward worked on criminal cases, extradition proceedings and investigations into international crimes including genocide, war crimes, crimes against humanity, torture, piracy and terrorism, as well as the Flight MH 17 trial.

In 2014-2018 he was professor by special appointment in International Criminal Law at the University of Groningen. He attended the University of Amsterdam and Columbia Law School. His publications include Direct Application of International Criminal Law in National Courts (2006), and the Kooijmans Lecture 2024: "International Criminal Law in Times of Turmoil".





#### **LUKE VIDAL**

Luke Vidal is a partner with SL V Partners law firm in Paris. He heads the International Litigation and Arbitration division of the firm and has advised and represented States, corporations, organisations and individuals before international and European courts and tribunals, including the International Court of Justice, the European Court of Justice, the European Court of Human Rights and UN Human Rights bodies.

He has been instructed in cases concerning the prevention of genocide, the application of international sanctions, the determination of international boundaries, and litigations regarding free trade and cross-border investments.

Luke is notably heading some of the main pro bono activities of SL V Partners, assisting victims of crimes against humanity, war crimes and terrorism.



#### **MARTIN HACKETT**

Martin Hackett is an International Prosecutor and Barrister with over 30 years' experience. Currently he works as an expert with Pravo Justice in Kyiv Ukraine as part of the Genocide and Conflict Related Sexual Violence teams within the International Atrocity Crimes Advisory group advising the Ukrainian Office of the Prosecutor General, with the United Nations Office of Counter Terrorism in Uganda and in Iraq and Kurdistan for a British Government project advising on fair trial rights.

Former Head of the War Crimes Prosecution Unit for the Special Prosecution Office for the Republic of Kosovo. Managing relationships with national prosecutors, liaising with the Serbian prosecution office and prosecuting high profile defendants within a challenging political context in the Kosovo Courts.

Between 2015-2021 Martin was Senior Trial counsel at the UN Special tribunal for Lebanon in The Hague investigating and prosecuting targeted terrorist attacks against political figures in Lebanon. He also continues to practice in the United Kingdom as a Barrister focusing upon counter terrorism and cases involving sexual violence.





#### NATIA NAVROUZOV

Natia Navrouzov is Yazda's Executive Director, a Yazidi-focused and global NGO established three weeks after the start of ISIS genocidal campaign against the Yazidi community in Sinjar.

She is a French-qualified lawyer specialising in international law, human rights, and transitional justice.

As a member of the Yazidi community, Natia has been instrumental in Yazda's initiatives since joining in 2018. She holds various positions within the organisation, including Project Manager and Interim Country Director. In 2021, she was appointed as Yazda's first Legal Advocacy Director. Under her leadership, Yazda collected testimonies of ISIS survivors and documented evidence from crime sites, and collaborated with international and national bodies, including the United Nations Investigative Team to Promote Accountability Against Da'esh Crimes (UNITAD), national war crimes units and the Office of Amal Clooney. Notably, her leadership played a key role in the conviction of several ISIS members in Germany, including for genocide against Yazidi victims. In 2019, Natia supported a group of Yazidi female advocates to establish the Yazidi Survivors Network (YSN) and campaigned with them for the passing of the Yazidi Survivors Law until its adoption in March 2021.

Before joining Yazda, Natia worked for a globally recognized law firm specializing in International Public Law and International Arbitration in Paris, as a Research Assistant at the London Court of Arbitration, and Assistant Lecturer at the Université of Panthéon-Sorbonne in Paris. Admitted to the Paris Bar, Natia holds a dual bachelor's degree in German and French Law from the University of Cologne (Germany) and Paris 1 Panthéon-Sorbonne (France); she holds Master's degrees in International Law from Paris 1 Panthéon-Sorbonne and Columbia University (USA), where she graduated as a Human Rights Fellow and Fulbright scholar, and was awarded the Davis Polk Fellowship.

Natia is also an Obama Foundation Leader.

#### TRADE LAW IN INTERESTING TIMES

Trump 2.0 and the war on trade – is it a tumultuous time ahead, or a new dawn of opportunities for the EU? Some argue that the current zeitgeist is not only the end of the Washington Consensus but the beginning of the end for the rule of law in international trade. But the shift we are witnessing in global power comes at a time of significant developments in the markets for services, and with a radically changing technological landscape on the horizon. In this conjuncture many believe there is a chance for the EU to not only come into its own but forge a new path in trade in services.



#### MR. JUSTICE DAVID BARNIVILLE

Mr. Justice David Barniville is the President of the High Court of Ireland. He was appointed a judge of the High Court in December 2017 after almost 27 years in practice as a barrister and Senior Counsel in the Courts of Ireland and in the European Courts. He was, and is again, also designated as the Arbitration Judge to hear all arbitration related matters in the High Court. David was appointed to the Court of Appeal in August 2021.

He was appointed President of the High Court in July 2022. In that role he is ex officio a member of the Court of Appeal, the Supreme Court and the Council of State.

In July 2018, David was appointed as a member of Ireland's National Group on the Permanent Court of Arbitration in The Hague and continues to hold that position. He was recently (2024) appointed to the ICC's Governing Body for Dispute Resolution. David is the current Chair of the Judges Forum of the International Bar Association (IBA). David was Chair of the Council of the Bar of Ireland (2014-2016) and Chair of Irish Rule of Law International (IRLI) (2015-2019). He was a member of the Bars of Ireland and of England and Wales (Middle Temple) (and 20 Essex Chambers in London). He is a Bencher of the King's Inns in Dublin and of Middle Temple in London and an adjunct professor of law at the University of Limerick & University of Galway.



#### **GEORGE PERETZ KC**

George Peretz KC is a barrister at Monckton Chambers, specialising in public and EU law, with strength in trade and competition law. He has represented the UK government on a range of EU and public law cases in the CJEU and various higher courts. He blogs and publishes widely on Brexit and trade issues. He was a founding member of the UK Trade Forum, and he has given evidence to various House of Lords and House of Commons committees on Brexit and trade related issues.

### SPEAKER BIOGRAPHIES: CLIMATE PANEL

The panel will be discussing the role of and limits on litigation as a mechanism to enforce climate obligations, including consideration of issues such as: the boundaries of judicial power and the extent to which this is a legal question rather than a political one; the different fronts from which challenges may come (public bodies, environmental groups, commercial actors resisting restraints, commercial actors such as windfarm developers seeking to enforce environmental imperatives set out in legislation, etc.); the extent to which downstream effects of authorised activities have to be taken into account and the limitations on a court's ability to take future uncertainties into account; and specific developments in different jurisdictions.



#### DAME ELEANOR SHARPSTON KC

Dame Eleanor Sharpston KC is a member of the Aarhus Convention Compliance Committee and Honorary Professor at the University of Edinburgh.

Following a distinguished career in private practice, she served as an Advocate General at the Court of Justice of the European Union from 2006 to 2020, where she presented over 340 opinions. She is a member of the Bar of England and Wales and the Bar of Ireland, a bencher of Middle Temple and an honorary bencher of King 1s Inns, Dublin.

In parallel, she has had a distinguished academic career, having lectured in EU law and comparative law, first at University College London and then, for many years, at the University of Cambridge, where she is now an Emeritus Fellow of King's College. She is a visiting professor at the Riga Graduate School of Law and an adjunct professor at Trinity College Dublin.

She is an Honorary Fellow of Corpus Christi College, Oxford, and of the British Academy; and holds honorary doctorates from Glasgow, Nottingham Trent, Stockholm and Edinburgh.



#### **HANNAH GODFREY**

Hannah Godfrey is a barrister based in the Law Library in Dublin. She is a graduate of the University of Oxford and the King's Inns, Dublin.

She specialises in EU and public law and regularly appears before the Irish Superior Courts, as well as advising a large number of public bodies.

She is a member of the EU Bar Association and formerly taught on the EU Advanced Law course at Trinity College Dublin.

She is currently treasurer of the European Circuit.





#### **ACLAND BRYANT**

### SPEAKER BIOGRAPHIES: MIGRATION PANEL

#### LEGAL PLUMBING: VALVES, TAPS & THE PIPEWORK OF IL/LEGAL MIGRATION

The panel will look at some of the drivers and consequences of "illegal", or irregular migration. This will touch on those who arrive in Europe with nothing, but who are still rich in rights; a polemic driving much of the unstable domestic politics in Europe. Discussions will include the relevance of Article 8 in the context of visa applications and how States manage this qualified right. The panel will also look at issues touching upon professional and business migration including with "third countries" such as Canada. Finally, the panel will consider the economic drivers motivating migration and appraise why migration is so difficult for States to control, despite the "tough" rhetoric and commentary reported in certain media outlets.



#### **HHJ RICHARD PEARCE**

His Honour Judge Pearce was called to the Bar of England and Wales in 1985. He practised in the sphere of common law in Manchester, specialising in clinical negligence and personal injury work, as well as medical regulation and professional negligence. He was has been a full time Judge since 2015, sitting initially in Chester and Liverpool and more recently in Manchester as a Specialist Circuit Judge in the Business and Property Courts.

He is the Judge in charge of the Circuit Commercial Court in Manchester and also regularly sits in the Chancery Division, King's Bench Division (Technology and Construction Court, Administrative Court and the general list) and the Upper Tribunal (Immigration and Asylum Chamber).



#### **NIKKI VREEDE**

Nikki is an immigration lawyer at Everaert Immigration Lawyers. She assists private individuals, with a specialisation in complex family reunification cases and permits based on medical and humanitarian grounds.

Chair of the Tort Reform & Access to Justice Group of PEOPIL (The Pan European Organisation of Personal Injury Lawyers). He represents family members and survivors of the Cutro and Pylos shipwrecks.


The closest tram stops are Binnenhof (Tram 1, 1A, 1B, & 10) and Oude Scheveningseweg (Tram 1, 1A, 1B, & 10), with Binnenhof being slightly closer to the address.

For Tram 1, 1A, 1B, & 10: Binnenhof Stop: This is the closest option, located within a short walk of the Burgemeester van Karnebeeklaan. Oude Scheveningseweg Stop: Also very close to and serves the same trams


The T.M.C. Asser Instituut (or Asser Institute) is a professional interuniversity centre of knowledge and research. The institute carries out research in private and public international law, European law, as well as all other related fields, including international commercial arbitration, international sports law and international humanitarian and criminal law. It was established in 1965 in The Hague and it is affiliated with the University of Amsterdam.

The institute is named after Tobias Michael Carel Asser (1838–1913), who was a Dutch jurist, and co-winner (with Alfred Fried) of the Nobel Peace Prize in 1911 for his role in the formation of the Permanent Court of Arbitration at the first Hague peace conference (1899). He also advocated for the creation of an international academy of law, which led to founding of the Revue de Droit International et de Législation Comparée

Pulchri Studio ("For the study of the beautiful") is a Dutch art society, art institution and art studio based in The Hague.


This institute began in 1847 at the home of painter Lambertus Hardenberg. Since 1893 the club has its residence in the villa at Lange Voorhout in The Hague. Membership is made up of painters, sculptors, photographers and art lovers, with members selected by a committee. An artist's membership allows them to exhibit their own works in the galleries of the Company.

You can walk from The Hague Central Station (15 minutes), or take tram 1 or 9 towards Scheveningen. If you come by car via the Utrechtsebaan, follow the signs 'centrum'. It is best to park your car in the Interparking Museumkwartier parking garage. You can also park under the Malieveld & the Heulstraat / Noordeinde parking garage.

Please note it is approximately 20-30 mins by tram and 40 minutes to walk between the Asser Institute and Pulchri Studio.

The ICC is some distance away from the centre of The Hague. We are <u>not</u> providing transport in either direction, you will need to make you own way there by bike, tram, taxi etc.


Do not forget your passport or other form of photographic ID, you will be turned away if you do not have ID with you.
